

2002 April


The .eu started with the adoption of a European Parliament and Council regulation (Regulation (EC) No 733/2002)

The European Co down public polic (Regulation (EC)




EURid is incorporated under Belgian law.

- >3.8 million registrations


Who is eligible? Any business, organisation or individual residing within the EU or in IS, LI or NO

Dispute resolution for .eu



When to start an ADR?

- You believe that you have a prior right to the domain name. For example, you hold a trademark on the name.
- The current holder registered or uses the name for speculative or abusive purposes.



ADR.eu



- Managed by the Czech Arbitration Court (cac.eu), an independent body in Prague (CZ)
- Conducted online and by email
- Resolved by independent panellists (mostly IP experts), not judges.
- Cases takes 4 months to resolve, on average
- In the language of the complainant

The alternative dispute resolution (ADR) for .eu domain name disputes is provided by the Prague-based Arbitration Court attached to the Czech Chamber of Commerce and the Agricultural Chamber of the Czech Republic (the "Czech Arbitration Court"). The Czech Arbitration Court administers ADR Proceedings according to ADR Rules and ADR Supplemental Rules, and in line with the Public Policy Rules for .eu of the European Commission (EC Regulation 874/2004).

Enter platform UDRP

UDRP (Uniform Dispute Resolution Policy and Rules) is an alternative dispute resolution scheme for all generic top-level domains (gTLDs) and some country-code top-level domains (ccTLDs).



.eu ADR based on:



Regulation (EC) No. 874/2004

 laying down public policy rules concerning the implementation and functions of the .eu TLD and principles governing registration

Regulation (EC) No. 733/2002

• on the implementation of the .eu Top Level Domain




ADR fees discounted in 2014

- Discount granted per each filed complaint, irrespective of the number of domain names in dispute and the type of panel requested
- Example: the fee for disputing one domain name before the single-member panel will be EUR 300 instead of EUR 1300





ADR: Facts and Figures



- Q2 2014: 12 ADR cases filed
- **Q1 2014: 14**
- 9 decisions published by the CAC, of which 4 resulted in the domain name being transferred to the complainant.
